Before, taking up the Agenda Item for discussion, the Vice-Chancellor (Chairman) expressed his concern about the teaching work, which is not being imparted in accordance with the time-table. He further added that a number of complaints are being received from the students that teaching schedule has not been followed in certain departments. A few of such complaints were sent to the Deans of Faculties as also the President, Jamia Teachers' Association. The Chairman sought to appeal to all Deans of Faculties to ensure that the classes are taken up strictly in accordance with the time-table.

Further, the Chairman also expressed his concern that most of the Departments are not organizing academic activities, such as seminars, lectures and extension lectures etc. He has requested all the HoDs of the Departments to organize seminars/lectures/extension lectures for creating an academic atmosphere in the Jamia campus.

Thereafter, the Agenda Item was taken up for deliberation.

AC-2008(II): Res.-1

Decision on the Model Guidelines of the UGC for re-employment of superannuated teachers.

The Majlis (AC) deliberated on the Model Guidelines for re-employment of superannuated teachers vide University Grants Commission's letter No. F.3-1/94(PS)Pt.file dated 16.2.2008. Some of the

members expressed that as the scheme of re-employment of superannuated teachers against the direct posts of Professor has long term implications, it would be not be proper to adopt the same in the University without thorough examination of the matter. Thus, after detailed deliberation, the Majlis (AC) resolved that the Model Guidelines of the UGC be referred to the President, Jamia Teachers' Association (JTA) for deliberation of the guidelines in its general body meeting and submit its report for consideration of the Academic Council.

The meeting concluded at 4.20 p.m. with a vote of thanks to the Chair.
