The Director of the Centre Chaired the meeting.

Following issues were discussed.

- 1. The Director welcomed the House and introduced the External and Internal members of the Committee of Studies to the House.
- i. Prof. Ujjwal Kumar, Delhi University and Prof. S.N.Malakar, JNU are External Members.
- ii.Prof. Mehtab Manzar and Prof. Naved Iqbal are Internal members from Jamia Millia Islamia.

This was the first meeting of the Committee of Studies of the CSSEIP.

- 2. The Director informed about restarting of M.A.in Social Exclusion and Inclusive Policy in the Centre. The M.A. Coursework was discussed and it was resolved to improvise the syllabus to identify core subjects under which the Papers may fall like History, Sociology, Political Science with thrust on Social Exclusion and Inclusive Policy.

- The Progress reports of Ph.D. scholars for September 2015 to March 2016 was endorsed.
- 8. Dr. Shaikh Mujibur Rahman informed about his desire of withdrawing his Ph.D. supervision of Mr. Swarna Kumar registered under him for Ph.D. Prof. Sabiha Hussain wished the same for the Ph.D. Scholar Mohammad Jasil PC registered with her for supervision.

They informed that the candidates are consistently not reporting any progress and hardly have any contact with their respective supervisors.

The House suggested that the issue of Ph.D. supervision withdrawal may be pursued according to ordinance followed/prescribed by the University/UGC in such matter.

A meeting of the Committee of Studies was held on 14th November, 2017 at 11am in the Centre. The following members were present:

The minutes of the earlier meeting held on 21/10/2016 was confirmed and the following agenda items were discussed:

- 1. The Director briefed about the Academic programmes which were held at the Centre during the period between last and this Committee of Studies.
 - a. The Khan Abdul Ghaffar Khan Lecture
 - b. Book Talks
 - c. Ph.D Weekly Seminar
- 2. The Director also made a note to the house about the Financial Grant received from the UGC for the centre and also about the faculty positions lying vacant in this Centre.

It was decided that on behalf of the Committee the centre should urge the University regarding financial grants for the programmatic development at the Centre and also urge the University for the recruitment of the Faculty at the earliest as no centre can properly function without these two important things and ultimately the students are the sufferers.

- 3. The Committee deliberated on the two important papers: one of Skill development and the other on Ability Enhancement which are compulsory papers offered in the MA. Social Exclusion and Inclusive Policy.
- 4. The papers of MA Course on Social Exclusion and Inclusive Policy was finalised with some changes as follows:
 - a. The title of the paper "Politics and Development" may be changed as "Politics, Development and Ideology".

- b. It was decided that one paper in the MA course shall be on Dissertation with 4 credit marks. Every teacher would have a specific no. of students to supervise the dissertation work. The teacher must meet students under the classroom environment to discuss and guide the dissertation research and writing.
- 5. The modalities of the Ph.D programme and it's course work was discussed and it was decided that it will be administered according to given guidelines in the new Ph.D Ordinance only.
- 6. The Committee approved the list of the Ph.D scholars who have submitted the six monthly Progress Report and it was decided that the supervisor should send letters to the scholars who have not submitted their six monthly reports and report to the Centre
- 7. The CRC of the Centre was approved.
- 8. The issue of the transfer of the Ph.D scholars under Prof. Sabiha Hussain and Dr. Meher Fatima Hussain from this Centre to the Sarojini Naidu Centre for Women Studies, JMI was discussed and it was decided that the decision in this regard should be taken by the Dean, F/O Social Sciences as there are some technical and administrative issues in this regard which might come in the way of transfer as requested. It was suggested in case such transfer not being effected, centre should appoint a co-guide from the Centre for each of these students.
- The arrangement of the Joint teaching with the Dr. K. R. Narayanan Centre for Dalit and Minorities Studies for MA Social Exclusion and Inclusive Policy shall continue as earlier.
- 10. The case of a Ph.D scholar Swaran Kumar Anand was discussed and it was decided that the Director shall do natural justice to the scholar by investigating the case therein according to the Rules and Regulations of Jamia Millia islamia and then put up the case in the next COS meeting of the centre.

Another case of a Ph.D scholar Ajit Singh was also discussed and it was brought to the notice of the House that if a student is not paying yearly fees or not meeting his supervisor for a long time or not intimating about his ongoing work then he/she is no longer entitled to continue as a scholar. Mr. Ajit Singh can

accordingly be informed and process for his disassociation with Centre can be initiated.

Further, it was decided that the Supervisor should maintain attendance of the Scholar and meet his/her scholar once in a week regarding his/her progress of work. Supervisor should intimate the office of the chosen day and time in the week for such meetings. Abstaining scholars should be formally intimated to the office by the supervisor. Attendance by supervisor should be submitted at the end of every month.

11. The committee approved the application of the Ph.D scholar Mr. Shahid Habib regarding his change of topic. He should be informed herewith.

At the outset the Director welcomed newly appointed faculty Dr. Hem Borker and Dr. Khalid Ansari as a new members. The Director also briefed the committee about the programmes undertaken at the Centre such as publication and photo exhibition.

Then the following agenda items were discussed:

1. Confirmation of the minutes of the last meeting held on 14/11/2017.

Point 10 was brought for deliberation by two faculty members viz. Dr. Mujibur Rehman and Dr. Arvind Kumar. Their objection on difference on approach between 10a and 10b was explained to them and objection was overruled. The clause 10c was also contested by both the above faculty members. It was explained that maintenance of attendance is now a statutory requirement and is to be done by the supervisor concerned.

The board recommended cancellation of Ph. D admission of Mr. Swaran Kumar Anand and Mr. Ajeet Singh as per rule under Ph.D Ordinance of the JMI. Both the scholars have failed to submit requisite annual fees, progress reports duly signed by the supervisor concerned. Supervisors also brought to the notice of the Committee that said scholars have failed in doing any academic work or have maintained contacts with them.

- 2. The M.Phil/Ph.D admissions were approved as per the minutes of the CRC meeting held on dates 29th November, 2017 and 2nd August, 2018.
- 3. The transfer of Ph.D scholars working under Prof. Sabiha Hussain and Dr. Mehar Fatima Hussain (as per the decision arrived in consultation with the Dean according to the directive of the last COS) to Sarojini Naidu Centre for Women Studies was approved.

Regarding one scholar Ms. Farhana Manzoor under the supervision of Ms. Meher Fatima Hussain, who is yet to be transferred due to pending NO DUES CLEARANCE, it was decided that the file of Ms. Farhana Manzoor should also be transferred to Sarojini Naidu Centre for Women Studies with a letter from the Centre that she has not submitted her No Dues certificate and had never reported the Centre in this regard.

- 4. A List of Progress Reports submitted by the M.Phil/Ph.D scholars upto 30th September, 2018 was approved with also a presentation made by scholars before the Committee. (list of submission and presentation is attached)
- 5. The Board endorsed Four New Papers with their syllabus introduced in MA Social Exclusion and Inclusive Policy.
