- 1. The minutes of the previous meeting were confirmed.
- The CoS approved the syllabus for the proposed B.A. (Hons.) Programmes in French and Francophone Studies, and Spanish and Latin American Studies. The Committee also discussed the feasibility of running this programme in light of additional workload and requirements. It was suggested to introduce the BA programme in a phased manner. The Committee also recommended that the present two semester course work should continue under the new M.Phil/ PhD integrated programme given the specific nature of interdisciplinary course-work. The matter will be placed before the Board of Management of the Centre.
- 4. The CoS recommended introduction of **German Studies** at the Centre and resolved that this matter be taken up at appropriate fora for further necessary action. The matter will be placed before the Board of Management of the Centre.
- 5. The CoS approved the list of Examiners for M.Phil dissertations of Mr. Tanvir Alam and Ms. Grace Mariam Raju.
- 6. The CoS approved the examiners and paper setters for the Annual Exams of the Language Proficiency Programmes.
