- 8. The BOS took the cognizance of the Show cause notice issued to following Research Scholars.
 - A) Mr. Amit Kumar: The BOS discussed his case as he could not clear the course work for two consecutive years. As per para 4 (b) of JMI Ordinance (IX) Academics, His admission stands automatically cancelled. The BOS therefore, recommended the cancellation of his Admission
 - B) Mr. Kuldeep Kumar: His reply to show-cause vide email dated 26/12/2017 sent to Head Applied Sciences and Humanities (enclosed herewith) requested the cancellation of registration from Ph.D. program was discussed. The BOS therefore, recommended the cancellation of his admission from the Ph.D. Program.

- C) Mr. Mohammad Akram: There was no reply received from the candidate in response to the show-cause issued to him and it was to put on record that he had not been attending the course-work. The BOS authorized the Head, Department of Applied Sciences and Humanities to serve him 2nd Show Cause and if no reply was received from the candidate, the third-Show-cause notice should be served to him after the elapse of 15 days from the issuance of the IInd Show-Cause notice. The matter is to be reported in the next BOS meeting.
- 9. With reference to BOS held on 13th November 2017, the representation of Ms Ayesha Rani, a Ph.D. Scholar registered under Dr. Mukesh Pratap Singh was discussed in the light of Dr. M.P.Singh comments. The BOS, in the said meeting authorized the then HoD, Prof. Ch. Wali Mohammad to discuss the matter with the research scholar. The BOS recommended that Prof. Ch.
