3. Approval of detail syllabi of MCA and PGDCA Programmes as per new structure approved in the last BoS meeting



A syllabus restructuring committee of M.Sc.(Bioinformatics) programme was constituted as per the respective ordinances of BoS comprising following members:



Minutes of the BoS Meeting held on Monday, the 30th July 2018

A meeting of BoS of Computer Science took place in the Committee Room of the Department to discuss the agenda items given below on 30th July 2018 at 12:30 pm. List of present members is attached (**Annexure I**). The agenda items discussed and resolved in the meeting are as follows:

1. Confirmation of Minutes of the last BoS Meeting held on 17th April 2018.

Since no observation received from any quarter, therefore the Minutes of the previous BoS meeting held on 17th April, 2018 were confirmed.

While confirming the minutes, the chair has taken up and reported about the order No.AC-4(77)/RO/2018 dt. July 17, 2018 (Date of order) (**Annexure-II**).

In response, the members present strongly felt that the power of BoS - a statutory body on subject matter is severely underline and first ever wrong precedence is being set to appoint supervisors on the choice of students by Dean, approved by VC, even setting aside Dean's own order/notification dated April 11, 2018, which was actually in line with the ordinance (**Annexure-III**). The said order dated 17th July 2018, is a sheer violation of JMI statute and ordinance, more specifically, statute 21 (Board of Studies)/3/(g) and ordinance 3(III)/1/(9), as Dean, FNS, has no power to revert the decisions of BoS and Supervisor cannot be change without the consent of current Supervisor.

Nevertheless, since the said order clearly state that "This has approval of the Vice Chancellor, JMI", therefore, it is binding on all employees of JMI with effect from 17th July 2018 (date of order), VC being Chief Academic Officer of JMI. The members wanted to request the higher authorities to review and set aside this order being against ordinance, for which chair informed that the same is already taken up in response of this order itself on very next day, bearing FTS No.: 465658/ACDCS-7304 dated 18th July 2018, however, did not get any response till date.

2. Endorsement of the last DC Meeting held on May 15, 2018.

The Minutes of the previous DC Meeting held on May 15, 2018 were endorsed without any comment.

3. Ph.D. related issues: Change of Ph.D. supervisor/Topic/JRF to SRF/Extension etc.

- Extension Request of one year for Mr. Md. Aslam Pervez, Ph.D. Scholar under the supervision of Dr. Jahirrudin has been approved (Attached).
- Request to Appoint of co-supervisor (Dr. Umar Farooq) of Mr. Irfan Rashid Thoker submitted with the consent of present Supervisor Prof S M K Quadri is approved (Attached).

3. Discussion/Endorsement of revised syllabi for PhD (Course Work), MCA, M.Sc. Bioinformatics & PGDCA


