The Board approved all the four syllabi.


Item No.3: Issues regarding Ph.D.

Item No.3: Issues regarding Ph.D.







It was resolved to authorize the Head of Department / Chairman, BoS to constitute a committee and work out the details and report in the next meeting of the Board.


Item No. 4: Appointment of Examiners
