- 1. Prof. Das welcomed the committee members and informed the committee about inability of Prof. Shakti Kak to attend the meeting.
- 2. The minutes of the last Committee of Studies (CoS) meeting was approved.
- 3. The date schedule, question setters, moderators and evaluators for the MA even semester (January to May, 2015) examination were approved.
- 4. Progress reports of PhD students for the last six months (January to May, 2015) was approved.
- 5. One-year extension has been granted to the PhD students Sunil Kumar and Pallavi Mazumdar as their supervisors are satisfied with their dissertation progress.
- 6. Admission in charge for new academic session, 2015-16 for MA and PhD were approved.
- 7. Mahvish Rahman, a PhD student, has changed her dissertation topic thrice. She has to make a presentation of her new synopsis before the faculty at the earliest. Falling to do so might affect her PhD candidature.

8. It has also been proposed that PhD students should make presentation after they return from the fieldwork.

- It has been proposed that PhD classes could be aligned with January semester as it will give more time to PhD students to get engaged in Centre's activities after the admission.
- 10. The committee examined the change of title proposed by Mr. Manoj Das. The committee was of the opinion that the changes proposed by the candidate was a minor change, further the candidate was in a final stage of submission, hence the committee decided to retain the old title of PhD dissertation.
- 11. Khalid Jamal, PhD scholar has not submitted 6-monthly progress report. The committee suggested to ask the candidate to submit an explanation note to be considered in the COS.
- PhD students, Arif Nadal and Tehzeeb Fatima, who changed their PhD topics, have to present their new synopsis before the faculty in August 2015.
- 13. It has been decided that all PhD students have to make 6-monthly presentation, which could be run in weekly or fortnightly seminar series format. One PhD student could be made coordinator of the seminar series for 6 months.
- 14. Bhrigu Talukdar, ongoing PhD student has been nominated as PhD seminar series coordinator from May to December, 2015. He needs to work with Dr. Taberez, who has been coordinating the Centre's seminar series in order to avoid overlapping.
- 15. 6-monthly progress report of the PhD students has to be submitted at least one week in advance before the scheduled CoS meeting.
- 16. The format for the 6-monthly progress report should be standardised. It has been proposed that students could submit two pages progress report.
- 17. It has been decided that an adjunct faculty cannot propos a new course, though s/he is free to teach a course.
- 18. A new course titled "Media Flow and Transcultrality" has been proposed by the Centre, which has been approved by CoS. However, the title and the content of the course has to be reworked.
- 19. A new course titled "Culture and Media in Contemporary South Asia" has been approved which will be offered to the students of South Asian Studies in Kashmir University.
- 20. The proposal to allow selected MA students to write 8 credit thesis has been approved. However, the nitty-gritty has to be worked out before implementing it.
- 21. Performa for panel of experts for recruiting new faculty has been approved.
