Since you will be working very closely with the MP and may be exposed to sensitive documents and information, you are required to adhere to the strictest standards of professional conduct and confidentiality.

The terms and conditions that you have to comply with are detailed in the annexure. Notwithstanding any other provision in this contract, Institute for Policy Research Studies reserves the right to terminate your Fellowship at any time if it feels necessary.

# Lecislative Assistant to Members of Parliament (LAMP) Fellowship 2016-17 Terms of Engagement

#### Training

- Training: Before you begin work with your MP, you are required to go through an intensive training
  programme. The training programme is scheduled from June 20 to July 15, 2016 and attendance is
  mandatory for the entire period of the training. Your performance and conduct will be monitored
  closely during the training period. Your suitability for the role of a LAMP Fellow will be reviewed and
  recssessed during this period. IPRS has the right to revoke your offer on account of unsatisfactory
  performance during the training period.
- Caracity building sessions: Between Parliament sessions, IPRS will conduct capacity-building sessions and organise interactions with experts on a periodic basis. These activities could range from a few hours of discussion with an expert to a three day workshop on a particular topic. Attendance for these events is mandatory. Any absence without prior approval will be dealt with strictly.
- 3. Delivery of Assignments: During the training programme and the workshop modules, you will be given various assignments. You must complete these in a timely manner. Deadlines will be strictly enforced. There will be a review of your work at regular intervals through the Fellowship.

#### Engaging with IPRS

No request from a LAMP Fellow personally or through any other channels, to be assigned to a specific MP will be entertained by IPRS. Any such attempt will be viewed negatively and may affect your participation in the Fellowship.

### Legislative Assistant to Members of Parliament (LAMP) Fellowship 2017-18 Terms of Engagement

**Duration:** The Fellowship commences tentatively in mid-June 2017 and requires your commitment till the end of the Budget Session of Parliament in 2018 (expected to be April/May 2018).

Stipend: You will receive a consolidated monthly stipend of Rs. 20000.

### Training

1. **Training:** Before you begin work with your MP, you are required to go through an intensive training programme. The training programme is scheduled from mid-June to mid-July 2017 and attendance is mandatory for the entire period of the training. Your performance and conduct will be monitored closely during the training period. Your suitability for the role of a LAMP Fellow will be reviewed and reassessed during this period. Institute for Policy Research Studies, hereinafter referred to as IPRS, has the right to revoke your offer on account of unsatisfactory performance during the training period.

2. **Capacity building sessions:** Between Parliament sessions, IPRS will conduct capacity-building sessions and organize interactions with experts from the academia/civil societies/think tanks etc on a periodic basis. These activities could range from a few hours of discussion with an expert to a two-day workshop on a particular policy area. Attendance for these events is mandatory.
