Dear Ms/Mr. Smriti Somaraj,

We are pleased to inform that you have been selected as a Fellow for the August cohort of the SBI Youth for India Fellowship (2018-19). The fellowship is being offered to you on the following terms & conditions:

**Period of Fellowship:**

- The fellowship will be for a period of 13 months with effect from 6<sup>th</sup> August 2018.

**Financial Support:**

- You will receive a stipend of Rs. 15,000/- per month for the Fellowship period
- You will receive a local transport allowance of Rs. 1,000/- per month for the Fellowship period.
