## SPECIAL CONDITIONS

#### ARTICLE 1 – PURPOSE OF THE AGREEMENT

- 1.1 The Institution shall provide support to the Participant for undertaking a mobility activity for teaching and training under the Erasmus+ Programme.
- 1.2 The Participant accepts the financial support as specified in Article 3 and undertakes to carry out the mobility activity for teaching and training as described in Annex I.
- 1.3. Amendments or modifications to the Agreement shall be agreed by both parties to this Agreement in the form of an Appendix or through one-sided notification of the amendment(s) provided to the Participant (by letter or by electronic message). The amendment will be confirmed by the Participant through the Participant's signature affixed to the Appendix or notification of the University about the approval of the amended conditions of financial support sent by a letter or by electronic message.

# ARTICLE 2 - ENTRY INTO FORCE AND DURATION OF MOBILITY

- 2.1 The Agreement shall enter into force on the date when the last of the two parties has signed it.
- 2.2 The mobility period shall start on 3<sup>rd</sup> of January 2019 y. and end on 9<sup>th</sup> of January 2019 y. The start date of the mobility period shall be the first day that the Participant needs to be present at the receiving institution and the end date shall be the last day the Participant needs to be present at the receiving institution.
  - One day for travel before the first day of the activity abroad and one day for travel following the last day of the activity abroad defined in Article 2.2 shall be added to the duration of the mobility period and included in the calculation for individual support. The Participant shall receive financial support to cover costs incurred in such two days.
- 2.3 The Participant shall receive financial support from Erasmus+ EU funds for 7 days of activity.
- 2.4 The total duration of the mobility period shall not exceed 2 months, with a minimum of 5 days per mobility activity. **This provision is applicable only to teaching mobility.** A minimum of 8 hours of teaching per week has to be respected for a mobility period lasting one full week or less. If the mobility period is longer than one full week, the number of hours which the Participant must teach in a week which is not a full week will be proportionally greater.
- 2.5 The Participant may submit any request concerning the extension of the mobility period within the limit set out in Article 2.4. If the Institution agrees to extend the duration of the originally planned mobility period, the Agreement shall be amended accordingly.
- 2.6 The Certificate of Attendance issued by the receiving institution shall provide the effective start and end dates of the mobility period.





- 3.1. The Participant shall receive **980 EUR** corresponding to individual support and **820 EUR** corresponding to travel. The amount of individual support is EUR **140.00** per day up to the 14<sup>th</sup> day of activity.
  - The final amount for the mobility period shall be determined by multiplying the number of days of the mobility specified in article 2.3 with the individual support rate applicable per day and adding the contribution for travel to the amount obtained.
- 3.2 The reimbursement of additional costs incurred in connection with special needs, when applicable, shall be based on the supporting documents provided by the Participant confirming that additional costs have been paid, up to the amount determined in the decision on the grant of additional funds connected with the special needs (reimbursement for costs actually incurred).
- 3.3 The Participant hereby represents and warrants that s/he has not received any other EU funds to cover costs already funded by EU funds for the period in which financial support will be granted as defined in this Agreement.
- 3.4 Notwithstanding Article 3.3, additional financial support from other source of funding granted in order to complete the teaching and training programme agreed in Annex I is permitted.
- 3.5 The financial support or part of it shall be recovered if the Participant does not observe the conditions of the Agreement. However, reimbursement shall not be requested when the Participant has been prevented from completing his/her mobility activities as described in Annex I due to force majeure. In such cases the Participant will be eligible to receive an amount which is proportional to the actual mobility period as defined in Article 2.3. Such cases must be reported by the Participant to the Institution immediately after the occurrence of a force majeure event and accepted by the National Agency.

#### ARTICLE 4 – PAYMENT ARRANGEMENTS

- 4.1 Within 14 calendar days following the signature of the Agreement by both parties, and no later than the start date of the mobility period, a pre-financing payment shall be made to the Participant representing 100% of the financial support specified in Article 3.
- 4.2 The Participant must provide proof of the actual dates of start and end of the mobility period, based on a certificate of attendance provided by the receiving organisation.

# ARTICLE 5 – PARTICIPANT'S MOBILITY REPORTS – online EU Survey

- 5.1. The Participant shall complete and submit the *online EU Survey* after the mobility abroad within 30 calendar days upon receipt of the invitation to complete it.
- 5.2 Participants who fail to complete and submit the *online EU Survey* may be required by the Institution to partially or fully reimburse the financial support received.

# ARTICLE 6 - INSURANCE

- 6.1 The Participant confirms that s/he is aware of problems connected with health insurance (including in particular in case of repatriation and specific medical intervention). The Participant must take out private insurance to cover costs of treatment during the time of travel and entire mobility period under the Erasmus+ teaching/training mobility programme.
- 6.2 The Participant undertakes to conclude an insurance agreement for the coverage of consequences of any misadventure.
- 6.3 It is recommended that the Participant holds a civil liability insurance (covering damage caused by the Participant at the mobility venue).
- 6.4 Participants who are Polish nationals must register with Odyseusz service maintained by the Ministry of Foreign Affairs.

# ARTICLE 7 - APPLICABLE LAW AND COMPETENT COURT

- 7.1 The Agreement is governed by the Polish law.
- 7.2 The competent court determined in accordance with the applicable national law shall have sole jurisdiction to hear any dispute between the Institution and the Participant concerning the interpretation, application or validity of this Agreement, if such dispute cannot be settled amicably.

On behalf of the Shastri Indo-Canadian Institute, I am pleased to inform you that your proposal is among the 6 projects that have been selected for funding in the areas of Mechanical Engineering, Biomedical Sciences, Urban Planning & Design, & Gender and Sexuality Studies.

Your application was evaluated by a selection committee who made recommendations for approval to the Executive Council of the Shastri Institute. In concurrence with the recommendations of the Adjudication Committee, the Executive Council has approved a grant of Rs. 5,00,000 (Rs. 5 lakhs) each for two years for your project on "Role of Poly (ADP-ribose) Polymerase-1 (PARP1) in Hypoxia-induced Thrombosis" in collaboration with Prof. Girish M. 

Some state and local governments, which hold responsibility under the

constitution for law and order, limited this freedom by maintaining or enforcing existing "anti-conversion" legislation and by not efficiently or effectively prosecuting those who attacked religious minorities.
