### 3. NON-EXCLUSITIVITY





B. by either Party at will or without cause with not less than one day's written notice or fee (as specified in clause 7 below) in lieu of notice.

C. By SC BR, with immediate notice, in case SC BR finds that the work is not being implemented by the Service Provider, at least according to SC BR's minimum standards and that the progress of the work is not satisfactory.

D. By SC BR, without any notice whatsoever, in case the Service Provider violates any policy of SC BR.

#### 7. Fees

The Service Provider shall be paid an amount of **Rs. 93,324/-** (Rupees Ninety Three Thousand Three Hundred and Twenty Four only) for conducting the workshop.




