ABSTRACT

This thesis on "Status of women and family in Iran before and after the Islamic Revolution of 1979 and India Today" is, most probably the first attempt to describe, analyse and determine the position of women of women in both Iranian and Indian society. It is divided into five following chapters:

First Chapter: Women in Islam and other religions of the East.

Second Chapter: The Iranian women in Pre-Islamic Revolution Era.

Third Chapter: The role and participation of women, in the Iranian Revolution-1979 and India in past thirty years.

Fourth Chapter:Status of woman and family in society, culture, education, politics, technology, and modern sciences in Iran and India today.

Fifth Chapter:Comparative study of Iranian women after revolution and Indian women after independence.

Iran and India are rightly regarded as the most ancient and civilized countries in the world. Some thousand years old civilization of these countries, because of its fascination, is still talked about as the most valuable legacy of two people. The race of Indian and Iranian people, as per the classification by the social scientists and linguists, has been the same Aryan. Iran and India have been in close contacts with each other since the time immemorial. Hence, Indian and Iranian civilizations have been immensely influenced by each other. This is one of the reasons that in the wake of the analysis of the status of Indian and Iranian women, the cultural, political and social commonalities during the past ages have been studied.
