### GUIDELINES FOR FOREIGN STUDENTS SEEKING ADMISSION TO M.PHIL./PH.D. PROGRAMME -2018

## 1. Eligibility Criteria for Admission

A candidate seeking admission to the Programme for Degree of Master of Philosophy (M.Phil.)/ Doctor of Philosophy (Ph.D.) must have obtained at least a second Class Masters Degree with not less than 55% of Marks from a University or a Degree recognized by the Jamia as its equivalent in the subject in which the candidate wishes to pursue a course of research, or in a subject allied thereto.

### 2. Admission to M.Phil./Ph.D. Programme

The candidate can apply on-line as well as offline for admission to the M. Phil./Ph.D. Programme on a prescribed form, available on the university's website: http://jmi.ac.in.

The application form shall be submitted to the <u>OFFICE OF THE FOREIGN STUDENTS</u> <u>ADVISOR, Room No. 20, OLD SRK HOSTEL, GATE NO. 8 JAMIA MILLIA ISLAMIA, JAMIA NAGAR, NEW DELHI-110025.</u> with the following documents:-

- a. A demand Draft of Rs. 1000/- drawn in favour of the REGISTRAR, JAMIA MILLIA ISLAMIA, payable at Delhi/New Delhi.
- b. Self-attested copies of all educational certificates
- c. Synopsis/proposal of research (duly signed by the applicant)
- d. Self-attested copy of valid Passport and Visa

Foreign students shall be exempted from the entrance test and interview for M.Phil./Ph.D. for the admission during 2018. *The application of foreign nationals shall be accepted on the basis of their SYNOPSIS submitted with the application form.* If the synopsis is not found suitable by the department/centre concerned, the application shall be rejected. However, the applicants may contact to the concerned department/centre to find a suitable guide to prepare their synopsis before the submission of the application form.

#### 3. Visa

Admission to the M.Phil./Ph.D. programme shall be given only on the PRODUCTION OF RESEARCH VISA. In case of Diplomats, if a foreign diplomats wishing to register to a M.Phil./Ph.D. Programme, he/she shall be required to undergo for a change of his/her visa status or NOC from the MEA to pursue Ph.D. programme. Sufficient time to obtain RESEARCH VISA shall be given.

Once the applicant considered provisionally for admission to M.Phil. / Ph.D. Programme, he/she shall apply for a RESEARCH VISA immediately. The necessary form (Form-G\*/Certificate of Affiliation) and provisional admission letter can be obtained from the Office of the Foreign Students Advisor.

# Following documents are required for obtaining Research Visa:-

- a. 3 sets of the Form-G/Certificate of Affiliation duly signed and stamped by the Head and Dean/Director of the concerned Department/Faculty/Centre, Foreign Students Advisor and Registrar, JMI.
- b. An undertaking from the applicant
- c. Itinerary
- d. Provisional admission letter from the university
- e. Letter of acceptance from the Supervisor
- f. Copy of the Synopsis
- g. Copies of all educational certificates
- h. Copy of valid Passport/Visa

Above documents will be submitted to the FRRO, Delhi OR Indian Embassy in the concerned country by the applicant himself/herself.

### 4. Course Work

All foreign students admitted to the M.Phil./Ph.D. Programme shall have to complete the course work offered by the concerned department/centre of Jamia Millia Islamia. They shall have to join the course work in the semester –I that follows the completion of their admission formalities.

As per Ordinance 9 (IX) para 4 (b), the scholar possessing M.Tech./M.Arch./MDS degree or a scholar securing more than 70 % (or equivalent CGPA) in M.Phil./Ph.D. Course work, Foreign Scholars and scholars having fellowship such as NET-JRF/DST-INSPIRE may be allowed to directly proceed for registration in Ph.D. programme.

### 5. Fees

A fee of <u>US \$ 1200 per annum</u> (equivalent in INR) shall be charged from foreign students. *In addition, Rs. 2000/- as admission fee and Rs. 8000/- as refundable/security shall also be charged.* The fee shall be payable in lump sum at the time of admission and no part payment shall be allowed.
