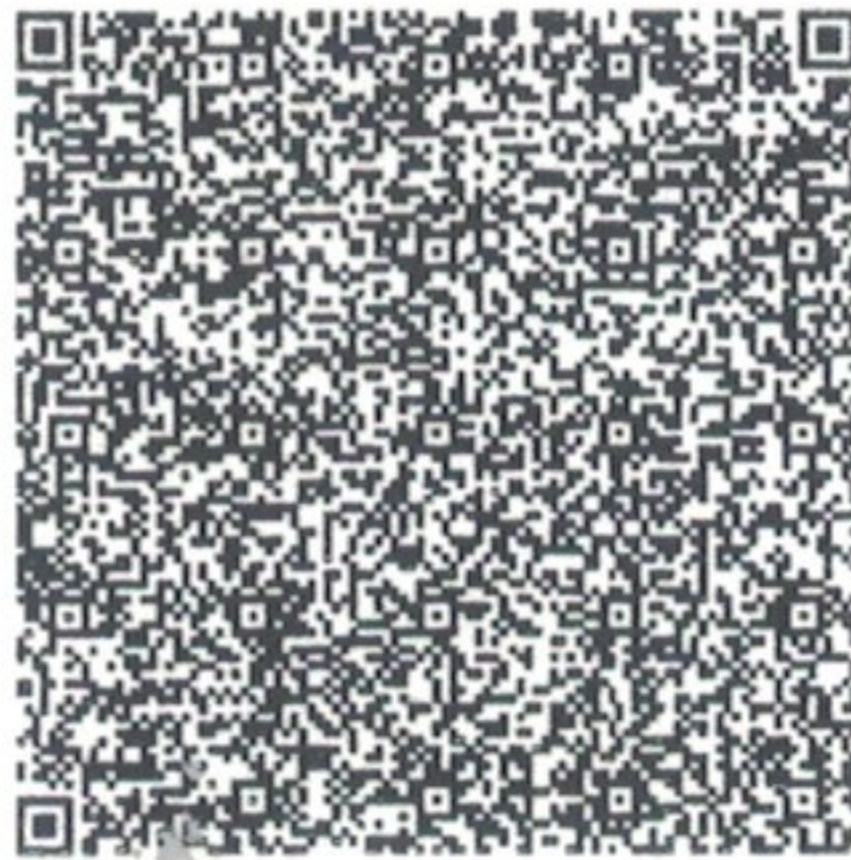

Memorandum of Understanding

This Memorandum of Understanding (MoU) is entered into between JAMIA MILLIA ISLAMIA (JMI) A Central University under the parliament act of Jamia Millia Islamia University, New Delhi represented by Registrar JMI.

And

DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA, represented by DIRECTOR & CHAIRPERSON, PULMONARY, SLEEP & CRITICAL CARE MEDICINE, METRO HOSPITAL & HEART INSTITUTE.

Sharing a common desire to extend and strengthen the functional relationship between JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA we the undersigned, mutually agree to share existing facilities and available expertise at our respective institutions viz. JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA MoU on **08.08.2025** which reads as follows:

ARTICLE 1: Areas of Cooperation

- i. The major objective is to establish a close linkage and functional coordination between DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA and JAMIA MILLIA ISLAMIA (JMI) for mutual cooperation towards the advancement of knowledge of the employees, faculty, scholars and students of both institutions.
- ii. JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA will both provide intellectual and infrastructure support for carrying out academic research in collaboration in the areas of mutual interest. A prior approval of each research activity under such collaboration is required from the competent authorities of both organizations. Mutually approved research projects will be executed without any financial liabilities on each other for recurring expenses after assessing the priority. The outcomes of the studies in terms of research papers, patents, products, etc. will be jointly shared by the individuals from both organizations.
- iii. JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA will encourage and provide facilities to faculty members of DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA and JAMIA MILLIA ISLAMIA (JMI) to explore and prepare joint proposals on thrust areas for funding. The technical activities and grant sharing between JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA shall be mutually agreed while submitting such proposals to funding agencies. The outcomes of the joint research in terms of research papers, patents products, etc will be jointly shared by individuals of both organizations.
- iv. JAMIA MILLIA ISLAMIA (JMI) faculty members can be Co-Guide for Ph.D. Programme of DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA and vice versa subject to adherence to the Ph.D. Ordinances of the respective universities.
- v. JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA may jointly organize Seminars/ workshops/ Conferences and short-term training programmes on topics of mutual interest.
- vi. The students training/posting /internship can be posted by JAMIA MILLIA ISLAMIA (JMI) to DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA or vice-versa.

ARTICLE 2: Financial Arrangements

- 2.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 2.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding with the institutional approval.
- 2.3 There shall be no financial liability on the patients. There shall be no travel liability on the patients of DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA



ARTICLE 3: Effect of Memorandum of Understanding

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create any legally binding or enforceable obligations, express or implied, under domestic or international law.

ARTICLE 4: Entry into Effect

This Memorandum of Understanding shall become effective on the date of signatures of both parties, or if the dates vary, then the date of the later signature.

ARTICLE 5: IPR

- 5.1 Where significant number of resources are from JAMIA MILLIA ISLAMIA (JMI) shall be the sole owner of any intellectual property developed during the course of the MoU and *Vice versa*.
- 5.2 When only a portion of its resources is supplied by JAMIA MILLIA ISLAMIA (JMI) ownership of any intellectual property developed jointly during the course of the MoU shall be vested in both parties of the Memorandum.

ARTICLE 6: Publications

- 6.1 Publications, if any, in respect of the activities covered under this MOU shall be in the names of involved personnel from both parties. In all publications (papers, reports etc.,) it will be duly acknowledged that the work has been carried out by JAMIA MILLIA ISLAMIA (JMI) and DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA under this MOU between the parties.
- 6.2 All ethical guidelines of research publication existent at both Institutions will be followed strictly.

ARTICLE 7: Force Majeure

The parties shall have no liability in respect of any delay in carrying out the activities or failure to carry out the activities under this MoU caused due to any acts of the government, or any circumstances outside the reasonable control of the parties hereto.

ARTICLE 8: Indemnification

Each party shall indemnify or keep indemnified the other party for any loss, cost and expenses caused to the other party due to the negligence, mishandling, for any other reason what so ever.

ARTICLE 9: Dispute Resolution

All disputes and differences concerning the validity, scope, meaning construction or effect of this MoU or any dispute or disagreement between the parties hereto as to any matter relating to this memorandum which can be settled by mutual discussion.

ARTICLE 10: Duration

The MoU shall be effective from date of signing and shall remain in force for a period of **Five (05) years** (as agreed upon).

ARTICLE 11: Penalty

No penalty will be given by JAMIA MILLIA ISLAMIA (JMI) or DEPARTMENT OF RESPIRATORY PHYSIOTHERAPY, METRO CENTRE FOR RESPIRATORY DISEASES, METRO HOSPITAL & HEART INSTITUTE, NOIDA, INDIA for non-performance or delay in performance during the course of the MoU.

ARTICLE 12: Termination

This Memorandum of Understanding may be terminated by either party with a minimum of Thirty (30) days written notice. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

ARTICLE 13: Coordinator

Name of the coordinator of both the institution must be mentioned in the MOU.
