NOTICE FOR ADMISSION FOR FIRST BDS SESSION 2021-22

1. All the candidates duly notified from MCC, DGHS, Govt. of India should physically present themselves for admission at the Faculty of Dentistry, Jamia Millia Islamia, New Delhi-110025 along with copy of provisional allotment letter.
2. For the admission process, all possible measures to ensure social distancing are being ensured. Use of face mask/face covers is mandatory at all times within the Faculty premises. Hand hygiene (sanitizer) and thermal scanning are available at the entrance gate.
3. Only asymptomatic candidates are permitted on the faculty premises.
4. Admission can be done till the last date notified MCC between 10 AM to 04 PM (Lunch time 01 to 02 PM).
5. Following documents are required in original along with self attested photocopies during physical reporting including 04 photographs similar to uploaded photos.
 - a) Allotment Letter issued by MCC.
 - b) Admit Cards of Exam issued by NTA.
 - c) Result/Rank letter issued by NTA.
 - d) Proof of passing the qualifying examination together with the marks sheet in accordance with the eligibility requirements for admission as mentioned in this prospectus.
 - e) Proof of age based on the certificate of High School/Secondary School or an equivalent examination.
 - f) Candidate has to bring his/her Four Passport size photograph.
 - g) Proof of entitlement for a particular reserved category issued by the competent authority.

- h) Character Certificate from the institution last attended and migration certificate.
- i) Candidate has to bring score card of NEET-2021 for admission in BDS Programme respectively.
- j) In case an intervening/gap period is involved, the candidate has to submit a certificate/Affidavit from Class 1 Gazetted Officer/ Notary Public for the entire intervening/ gap period showing year-wise preoccupation and non-indulgence in any criminal activities after leaving the institution last attended.
- k) Proof of permanent address as declared in the Application Form with the name of the nearest Police Station and the District.
- l) Execution of Bond agreement.
6. The admission procedure shall be deemed provisional till completion of all formalities.
7. In ref. to MCC Notice Ref.U-11011/08/2021-MEC dated 03.02.2022, those candidates who are Covid-19 positive/likely symptomatic can send the scanned copies of documents as per S.No. 05 above to email **fdn@jmi.ac.in**.

Urgent Attention Candidates/ Colleges:

Keeping in view, the prevailing adverse situation of COVID pandemic, MCC/ MoHFW has decided to allow candidates of UG Counselling 2021 for **HYBRID MODE OF REPORTING** i.e Candidates who have been allotted seats by MCC in UG Counselling 2021 can report in both **ONLINE/ OFFLINE** mode at the allotted college.

In reference to above the Candidates/ Colleges may note following points:

1. Candidates who are opting for **Online Reporting/ E-joining** can join the allotted college by sending a confirmatory email regarding acceptance of seat and uploading scanned copies of relevant documents as mentioned in Information Bulletin. Hence, the verification of documents of such candidates will be done by the college through scanned copies. **However, kindly note that candidates who want to give willingness for Upgradation for Round-2 while retaining Round-1 seat, have to 'Report physically' at the allotted institute to confirm their admission.**
2. Candidates reporting 'Online' or doing 'E-joining' should ensure that they receive 'Admission Letter' generated online, through MCC portal by the college otherwise their admission will be considered 'Null & Void'.
3. Email Id/ Phone Number of the Principal/ Nodal Officer of college for Online Reporting should be displayed on respective college websites.
4. Candidates can pay the requisite fees to the allotted college through their authorized portal to be notified in advance by the college authorities on the college website.
5. All admissions made online will be deemed **Provisional**, and will be considered **Final** only on verification of documents at the time of Physical Joining and Medical Fitness at the college. The college authorities should generate '**Admission Letter**' online through intramcc portal for candidates reporting online and send one copy of Admission Letter to candidate and endorse one copy to MCC on Email Id: ugmconlinereporting@gmail.com

6. The candidates who join their seat of Round-1 and later want to resign the same can do so till **04:00 P.M of 16th February, 2022** after **which they will be considered as part of Round-2 and same rules will apply as applicable for Round- 2 of counselling**. Candidates should ensure that the Withdrawal/ Resignation Letter should be generated 'online' by the college through portal provided by MCC. Resignation taken in offline mode will be treated as 'Null & Void'.
7. Candidates who want to avail 'Free Exit' option in Round-1 need not Report at the allotted college.
8. By default the candidates should Report physically at the allotted college. 'Online Reporting' or 'E-joining' should be opted only in case of COVID protocol or in case the candidate himself/ herself is suffering from Covid, with prior consent of allotted college.
