The *Majlis-i-Talimi* (Academic Council) in its meeting held on 05.05.2025 has approved the following amendment in the *Para 3* of the **Regulation R-35 (R-XXXV) (Academic)** captioned, 'Counting of Attendance of Students' in respect of BDS programme:

Existing provision	Amended provision
3. Classes of the consecutive semesters/years1st working day of the respective semester/year.	No Change
Provided that in the Bachelor of Dental Surgery (B.D.S.) course where there is a provision of 'supplementary examination' as per the ordinance of the said course, if a student passes the supplementary examination, his/her attendance shall be counted from the date of his/her provisional admission. However, if a student fails in the supplementary examination, his/her attendance shall be counted from the date of his/her re-admission to the previous class, which he/she has been reverted back.  Provided further that	Provided that in the Bachelor of Dental Surgery (B.D.S.) course where there is a provision of 'supplementary examination' as per the ordinance of the said course, if a student passes the supplementary examination, his/her attendance shall be counted from the date of his/her provisional admission.  If any student fails in the supplementary examination, he/she shall be reverted back to the previous class with re-admission. The students are advised to attend all Theory/Clinical classes, in the subjects in which they have failed and must re-appear in the internal Assessment Examinations to improve and achieve the necessary academic standard. However, the attendance of previous year will be considered.
Provided further that if his/her admission shall stand cancelled.	No Change
