The benefit of up-gradation is covered under the following provisions of the above said Scheme:

1. The Scheme, as applicable in Jamia, shall be enforced strictly in accordance with the guidelines laid down in the Office Memorandum bearing no 35034/3/2008-Estt, (D) dated 19.05.2009 and 22.10.2019 issued by the Ministry of Personnel, Public Grievances & Pensions and the letter of UGC No. F.4-5/2009 (JCRC) dated 9.07.2010 and clarification vide O.M. No. 35034/3/2008-Estt.(D) dated 16.11.2009 of Ministry of PPG & P, (Department of Personnel & Training) Govt. of India.
2. It is inter alia, clarified that the ACP/MACP Scheme provides, placement in the higher scale/grade pay respectively (through financial up-gradation) to the employees on personal basis only and no new posts shall be created for the said purpose. Such envisaged placements shall also not amount to any functional/regular promotions. Furthermore, no additional financial up-gradation shall accrue to any senior employee on the ground that the junior employee in the grade has got higher scale/grade pay under the then ACP/MACP Scheme respectively.

3. The benefits under the then ACP/MACP Scheme have been adopted by Executive Council and admissible from the dates on which the employees became eligible.
4. The employee concerned will have the option to be exercised in writing within a period of one month from the date of issue of this order, either to have his/her pay fixed in higher scale/ grade pay (as per FR-22) from a date of up-gradation or from the date of his/her next increment in old post. The option once exercised will be final.
5. The arrears will be paid on availability of funds.
6. The Finance & Accounts Office may obtain an undertaking from the employee concerned that in case any discrepancy has been found in the eligibility the financial upgradation granted will be withdrawn.
