Presently working as Professor of Law, at the Faculty of Law, **Jamia Millia Islamia** (a Central University located in New Delhi)

I've held the position of Dean twice at the Faculty of Law, Jamia Millia Islamia, New Delhi. I completed my second term in the month of September, 2016. In my tenure as Dean I recently started a self-financing five year B.A.LL.B.(Hons) programme at the Faculty of Law.

Recently, I also launched the first issue of the Jamia Law Journal being the editor-in-chief of the same.

I was also a Chairperson of the Ordinance Committee of Jamia Millia Islamia, New Delhi.
