Tanweer Fazal specializes in political sociology with specific interest in sociology of nationalism and nationhood, minority and ethnic identities and social movements. Prior to joining this Centre, Tanweer Fazal has been a senior consultant with Prime Minister's High Level Committee, popularly called, Sachar Committee wherein he worked specifically on status stratification with particular reference to the OBCs among the Muslims of India. He was closely associated with the Gujarat Harmony Project aimed at reconciling hostilities between communities following the anti-Muslim carnage of 2002 and was instrumental in drafting a 350 page report titled, *Civil Society Intervention in Post-Godhra Gujarat: Reconciliation from Below.* As a principal researcher, he was involved in administering and bringing out reports on the ICSSR funded baseline survey of two minority concentrated districts, North-east Delhi and Bhopal. Earlier, Tanweer Fazal taught sociology at the Government Degree College, Chhaprauli, Baghpat and at the Department of Sociology, Jamia Millia Islamia, New Delhi.

Fazal has been an ex-officio member of the *Planning Commission's Working Group on Empowerment of Minorities for the 11th Five Year Plan*, a research consultant with the *National Minorities' Commission* and a consultant for *Department for International Development(DFID)*, Government of U.K, for the evaluation of MHRD's Mahila Samakhya Programme with the brief to evaluate the participation of Minorities in such schemes. He is also the member of the international editorial advisory board of the journal, South Asian History and Culture published by Routledge, UK.

For his M.Phil dissertation submitted at the Centre for the Study of Social Systems, JNU, he worked on *Nation and Nationhood in South Asia: An Analysis of Muslim Conceptualisations.* His doctoral thesis was titled, *Nation-state and Minority Rights in India: Comparative Perspectives on Muslim and Sikh Identities.*
