Decision on the revision of the qualifications for the post of Section Officer and Office Assistant in Jamia Millia Islamia.

The Majlis (Executive Council) considered the recommendations of the Committee constituted by the Vice-Chancellor to review the existing qualifications for the post of Section Officer and Office Assistant in Jamia Millia Islamia and approved the same as under:

A. <u>Approved Qualifications for Section Officer</u>

- 1. Bachelor's degree from a recognized University.
- 2. 5 years experience in a post of Assistant or equivalent or 10 years experience in the post of Sr. clerk or equivalent in a reputed organization (Govt./ Private).
- 3. Proficiency in Noting and Drafting.
- 4. Knowledge of Computer especially M.S. Office.

B. <u>Approved Qualifications for Office Assistant</u>

- 1. Bachelor's degree from a recognized university.
- 2. 5 years experience in a post of UDC or equivalent or 10 years as LDC or equivalent in a reputed organization (Govt./ Private)
- 3. Proficiency in Noting and Drafting.
- 4. Knowledge of Computer especially M.S. Office.
- Note: The University will conduct a written examination & interview to assess the suitability of the candidates for the above posts. The written test will have the following major components amongst others:
 - a) Essay writing
 - b) Drafting
 - c) English Grammar
 - d) General Office Procedure
 - e) Service Rules, etc.
 - f) Computer application.
- Weightage of interview marks shall not be more than 15% of total marks.
- Knowledge of Urdu and Hindi shall be desirable qualification for all the Teaching and Non-teaching posts in Jamia Millia Islamia.

Approval of a policy decision on the requests being received from religious organizations for booking of Auditorium in Jamia Millia Islamia to organize programmes.

"Ph.D. degree with the first Class Bachelor's Degree in (Civil Engineering) and Master's Degree in (Civil Structures) with three years experience in Teaching/Industry.

Or

First Class Bachelor's Degree in (Civil Engineering) and Master's Degree (Civil Structure). Professional work which is significant and can be recognized as equivalent to Ph.D. degree and Five Years experience of Structural Engineering.

Desirable:

"Three-years experience in Teaching Structural Engineering in B.Arch. Program".
