ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the recognition was granted by NRC to Institute of Advanced Studies in Education (Deptt. of Teacher Training) Jamia Millia Islamia, Jamia Nagar, New Delhi-110025 for B.Ed. Course vide order No. F.No. F-3/DH-118/2009/702-706 dated 20.04.2000 with an annual intake of 200 seats with effect from the academic session 2000-2001.

3. AND WHEREAS, the institution Institute of Advanced Studies in Education (Deptt. of Teacher Training) Jamia Millia Islamia, Jamia Nagar, New Delhi-110025 has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed., which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely.

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Institute of Advanced Studies in Education (Deptt. of Teacher Training) Jamia Millia Islamia, Jamia Nagar, New Delhi-110025 for conducting B.Ed. programme of two years duration with an annual intake of 200 for four basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein.

6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

1: Application for ITEP at all the four levels, Foundational, preparatory, middle and secondary levels covering for all the existing subjects.(BA/BSc/BCom)

In IASE, we are already having teacher education programme for the four levels:

I) B.Ed Nursery, (foundational)

II) D.El.Ed, (preparatory and middle)

IV) BEd General catering to secondary stages.

For retaining the **comprehensive nature of the Department**, we would apply for one unit each of the four levels.

2: We have already 18 teaching subjects at the secondary level, which would be retained in the ITEP at the Secondary level.

The Departments of Jamia offering these subjects need to be contacted for the Disciplinary courses/interdisciplinary courses.

Department of Home Science

3: The curriculum provided by NCTE for the four levels (the ITEP structure) having a total of 160 credits for the BA BEd/BSc BEd/BCom BEd which is similar and is explained below is to be adopted .

II. **Student induction Programme** -2 weeks in each semester

III. **Foundations of education** is for a total of 30 credits
