

**SUBAWARD AGREEMENT
("Agreement")**

This Agreement is executed:

BETWEEN	YORK UNIVERSITY ("York") 4700 Keele Street North York, Ontario, M3J 1P3
AND	JAMIA MILLIA ISLAMIA ("JMI")

York has been awarded a grant from the Shastri Indo-Canadian Institute ("Sponsor") for performance of research under a grant agreement Collaboration Research Project 2011-13 ("Main Agreement"), attached hereto and incorporated by reference as Appendix 1, for the following project:

PROJECT ENTITLED: Mediated Democracy, Diversity and Visual Publics ("Project")

YORK REFERENCE: Cost Centre No. 560073

PRINCIPAL INVESTIGATOR at YORK: Daniel Drache ("York Researcher")

CO-INVESTIGATOR AT JMI: Biswajit Das ("JMI Researcher")

CONTRACT PERIOD: January 1, 2011 - December 31, 2013

JMI shall collaborate with York on the Project by performing the following work

RESEARCH TASK: The work as outlined in the Main Agreement, attached hereto as Appendix 1 and incorporated herein by reference, which work is applicable to performance by the JMIU Researcher. This work is also outlined in the grant application which proposal was agreed to by all parties. Specifically the project work will address the issue of democracy through the lens of media diversity. ("Research Task"). JMI agrees to obtain written approval from York for any major deviation from the Research Task.

PERIOD OF AGREEMENT: It is recognized that the work will carry on beginning January 1, 2011 to December 31, 2013, as set out in the Main Agreement.

RESEARCHERS: The researcher responsible for the conduct of the work by JMI is professor Biswajit Das ("JMI Researcher").

The researcher responsible for the conduct and overall coordination of the Project at York is Professor Daniel Drache ("York Researcher").

FUNDING: The total amount of funding for the work under this subcontract is the sum of 67,000 Rupees to support the rental of video conference equipment at JMI for four video conferences committed to by the research proposal. Administration of monies provided to JMI will comply with the terms and conditions of the Main Agreement. All expenses incurred in the performance of the work must comply with the Main Agreement.

PAYMENT/REPORTS: York shall forward the funds to JMI on signing of this Subaward Agreement. JMIU shall work with York and the York Researcher to complete the applicable reporting requirements under the Main Agreement. JMI agrees to provide York with any financial reporting or other documentation required by the Sponsor, and will ensure expenses are in compliance with the eligible costs and budget included in the Main Agreement.

STANDARD INSTRUCTIONS AND CONDITIONS: This Subaward Agreement is subject to the conditions of the Main Agreement which are incorporated herein by reference, and as Appendix 1. All communications concerning the administration of agreement with the Sponsor shall be made through York.

LIABILITY: The parties shall indemnify and hold each other harmless including its officers, directors, employees and agents from and against all liabilities, claims, losses, costs, damages, charges and expenses whatsoever, including reasonable legal fees and disbursements, in any way caused by or arising directly or indirectly from a breach of a representation, warranty or covenant in this Agreement or as a consequence of any negligent act or omissions in the execution of responsibilities; any inaccuracy or misrepresentation in any representation or warranty; or any breach of any covenant or agreement contained in this Agreement.

The liability of York for any direct damages is limited to the monies paid hereunder. In no event is York liable for any special, incidental, indirect, consequential or other similar damages, whether based on breach of contract, tort (including negligence) or otherwise.

ASSIGNMENT: JMI shall not sell, assign, encumber, licence or otherwise transfer any of its rights, duties or obligations under this Agreement without the prior written consent of York.

GOVERNING LAW: This Agreement shall be governed by and construed in accordance with the laws of Canada and the laws of the Province of Ontario applicable therein.

CHANGES: No change or modification to the Agreement is valid unless it is in writing and signed by both parties.


