Consideration on the proposal of Dean, Faculty of Natural Sciences for change in examination/evaluation in the Faculty.

The Majlis (AC) considered and approved the proposal of the Dean, Faculty of Natural Sciences for change in examination/evaluation mechanism to promote continuous learning/evaluation of the students under the present semester system as proposed and decided in the meeting held on 27th June, 2018 of all Heads of the Departments, Faculty of Natural Sciences:

- (I) Internal Assessment tests shall be of 40% marks instead of 25% in all theory courses. There will be 02 mid-semester tests for internal assessment of 20% marks each, while for the laboratory/practical courses, it will remain unchanged;
- (II) The end-semester examinations shall be of 60% marks instead of 75%;
- (III) The passing criteria will be applied on combined marks obtained in internal assessment tests & the end-semester examination. Candidates will not be required to pass separately in the internal assessment tests and end-semester examinations; and
- (IV) The end-semester examination duration will be 3 hours.
