The Majlis (EC) noted that Mr. Faisal Alam got admission in M.A. (Mass Communication) programme in AJK Mass Communication Research Centre, JMI during academic session 2013-14 on production of B.A. degree from CMJ University, Meghalaya and completed his M.A. (Mass Communication) programme in 2016. The Majlis (EC) also noted that Mr. Faisal had submitted fake B.A. Mark-sheet as communicated by CMJ University, Meghalaya (Annexure-XX). A notice dated 17.08.2017 was issued to Mr. Faisal Alam giving him an opportunity to offer his explanation within 15 days on receiving of the notice, but no information has been received from him (Annexure-XXI).

The Majlis (EC), after going through all the above stated fact, resolved to cancel M.A. (Mass Communication) degree and admission of Mr. Faisal Alam on production of fake B.A. Degree.

Consideration on the proposal for earmarking of the residential houses in Khan Abdul Ghaffar Khan Enclave for the Officers of the University

The Majlis (EC) noted that the official residence of Vice-Chancellor, JMI, located in Khan Abdul Ghaffar Khan (KAGK) Enclave, is earmarked for

residential accommodation under University rules. However, other residential houses i.e. A-106, A-107, A-108, A-109 & A-110 in the KAGK Enclave are not earmarked for residential accommodation for the dignitaries, i.e. Pro-Vice-Chancellor, Registrar, Finance Officer & Controller of Examinations etc.

The houses once vacated by the occupied incumbents shall be earmarked for the officers of the University as proposed above.

The Majlis (EC) went through the request of DMRC, vide letter No. DMRC/PM-7C/12 dated 24.03.2017 for revised land requirement of 28 sqm in place of 4 sqm at Khasra No. 68, Okhla Village for relocating the transformer, as per existing electricity norms (Annexure-XXII). The DMRC has informed that earlier they had requested for 4 sqm land.

The Majlis (EC) also noted that the request of DMRC regarding requirement of 4 sqm land was placed in the Majlis (EC) in its meeting held on 10.03.2017 wherein it was resolved to consider the request of DMRC to provide 4 sqm land on permanent basis to relocate the transformer from the existing location at the land of Irrigation Department to Jamia's land in the larger public interest for smooth traffic flow on the main road (Annexure-XXIII).

Further, the Majlis (EC) noted that the DMRC submitted a proposal that the requisite cost of this land will be paid by DMRC as made earlier or otherwise DMRC will give equivalent land area to Jamia in the newly acquired land behind Nom-Chomsky building.

The Majlis (EC), while noting all the above stated facts, considered and approved the request of DMRC for requirement of 28 sqm land in place of 4 sqm land at Khasra No. 68, Okhla Village for relocating the transformer and getting equivalent area of land behind Noam-Chomsky complex.
