The Majlis (EC) after due deliberations noted the above lapses amounts to misconduct and financial irregularities and resolved that penalty of withholding of one increment with cumulative effect be imposed on Prof. Nuzhat Parveen Khan.

After due deliberations, the House recommended removal of Dr. Sarfraz Ahmad, Assistant Professor, Department of Persian from the services of JMI as Assistant Professor in accordance with the Statute 37 of JMI Statutes.
