TO CONSIDER THE APPEAL OF PROF. SONYA SURABHI GUPTA (UNDER SUSPENSION), CENTRE OF SPANISH AND LATIN AMERICAN STUDIES, JAMIA MILLIA ISLAMIA IN TERMS OF ORDER PASSED BY THE HON'BLE HIGH COURT OF DELHI

DECISION

The Executive Council considered the appeal, in terms of order dated 02.02.2023 passed by Hon'ble High Court of Delhi, of Prof. Sonya Surabhi Gupta, Centre for Spanish and Latin American Studies dated 18.11.2022 wherein she pleaded that she has not violated any rules of the University. The House observed that prima facie, she has violated the 'Rules of Service Agreement' as well as the UGC Regulations regarding terms & conditions of teachers and an inquiry is already underway to submit its report, therefore, the House does not find any ground to review her suspension and interfere at this stage. Consequently, her appeal dated 18.11.2022 is dismissed, as it is devoid of any merit.
