

The University of Delhi, established and incorporated as a teaching and affiliating University of the Delhi University Act, 1922 (acting through its Registrar, and authorized signatory, Dr. Vikas Gupta).

WHEREAS it is statutory object of the Jamia Millia Islamia to disseminate and advance knowledge by providing instructional, research and extension facilities in such branches of learning as it may deem fit and it shall endeavour to provide to students and teachers the necessary atmosphere and facilities for the promotion of:

- i. innovations in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality;
- ii. studies in various disciplines;
- iii. interdisciplinary studies;
- iv. national integration, secularism and international understanding.

AND WHEREAS the Jamia Millia Islamia is empowered in terms and provisions of section 6(i) and (x) of the Jamia Millia Islamia Act to co-operate, collaborate or associate with any other University or authority or institution in such manner and for such purposes at it may determine.

AND WHEREAS The University of Delhi has been granted the power under the provision of Section 4(1) and (5) of the Delhi University Act, 1922 inter alia to provide for instruction in such branches of learning as the University may deem fit, and to make provision for research and for the advancement and dissemination of knowledge, and has the powers to cooperate with other Universities and Authorities in such manner and for such purposes as the University may determine.

NOW THEREFORE in furtherance of the objects of the respective institutions, to give an impetus to the concept of the Meta University, the competent bodies of both, the Jamia Millia Islamia and University of Delhi on 21st September 2012 signed MoU for a period of Five years (this was further extended up to 20th September 2022 by a fresh MoU on 6th September 2017) and consented, agreed and decided to offer a joint Degree Programme in the discipline of Master of Mathematics Education (Equivalent to M.Sc. Mathematics Education).

Subsequently, the first Meta University Program of India, which is presently known as M.Sc. (Mathematics Education), was started by enrolling the first batch of students in January 2013. The administrative responsibility of running the Meta University Program at the University of Delhi has been assigned to Cluster Innovation Centre and that at Jamia Millia Islamia has been assigned to A.J.K. Mass Communication Research Centre.

As per the said MoU, dated 21st September 2012, the details of the efficacious implementation of the intent of MoU, inclusive of course content, teaching methodology, examination related issues, theme implementation and other collateral and incidental aspects were jointly worked out on mutually acceptable terms within the parameters of the policies, rule and regulations of both the institutions.

As the Memorandum of Understanding dated 6th September 2017 is valid up to 20th September 2022 thus through this MoU, the competent authorities of the University of Delhi and Jamia Millia Islamia agreed to renew and extend the said MoU for a period of 01 year w.e.f. 21st September 2022 on the same terms and conditions as specified in the original MoU dated 21st September 2012 and MoU dated 6th September 2017.

The parties to this Memorandum of Understanding may, by mutual consent, add, modify, reform, delete, cancel, review or reverse any condition(s) herein incorporated.

This Memorandum of Understanding (MoU) shall remain in force for a period of One year from 20th September 2022, and may be terminated by either side by giving a six months' notice to that effect in writing. However, notwithstanding the intent to terminate this Memorandum, all rights, obligations and corresponding duties subsisting shall be respected and mandated till the finalization and accomplishment thereof.
