# MEMORANDUM OF UNDERSTANDING BETWEEN

# JAMIA MILLIA ISLAMIA, NEW DELHI, INDIA AND

# SAVE THE CHILDREN, BAL RAKSHA, BHARAT SOCIETY

First party: JAMIA MILLIA ISLAMIA, a Central University under an enactment of the Parliament of India (i.e. the Jamia Millia Islamia Act, 1988) and is a body corporate with a perpetual succession represented through its Registrar Professor Shahid Ashraf.

Second party: Save the Children, a society registered under the Societies Registration Act, 1860 having Head Office at Plot No. 91, 1<sup>st</sup> & 2<sup>nd</sup> Floor, Sector-44, Gurgaon-122003, Haryana, India.

AND WHEREAS it is the Statutory object of Jamia Millia Islamia University to disseminate and advance knowledge by providing instructional, research and extension facilities in such branches of learning as it may deem fit and it shall endeavour to provide to students and teachers the necessary atmosphere and facilities for the promotion of:

- Innovation in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality.
- II. Studies in various disciplines:
- III. Inter disciplinary studies,
- IV. National integration, secularism and international under-standing.

NOW THEREOFRE the Jamia Millia Islamia and Save the Children Society have intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop Training workshop on Peace Education for the State of Jammu & Kashmir.

#### 1. FIELD OF COOPERATION:

# Role of the First Party Jamia Millia Islamia

- a. Develop relevant training content on peace education for teachers in J&K in consultation with relevant stakeholders (teachers, student in J&K; Save the Children's Child Protection and education experts; scholars, etc)
- b. Lead pilot training, based on newly developed content, and finalize content based on a participatory review and subsequent feedback.
- c. Finalize the training module for wider use and dissemination.



## Role of the Second Party Save the Children Society

- a. Bring together teachers and relevant stakeholders to develop the peace education content.
- b. Work with Jamia Millia Islamia in development of relevant content and pilot it with set of 40 teachers in the State.
- c. Collect evidence on the use/impact of Peace Education delivered (from teachers, children, etc) and advocate with the government for its upscaling.

#### 2. EXCHANGE OF STUDENTS / TEACHERS:

- a. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects. Teachers, researchers, guides and students of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both Jamia Millia Islamia and Save the Children Society.
- b. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be mutually worked out according to and by taking into account the rules, regulations and policies of both Jamia Millia Islamia and Save the Children Society.

#### SCOPE OF WORK:

- a. Under Peace Education, a focused partnership is envisioned with the 'Nelson Mandela Centre for Peace and Conflict Resolution' Jamia Millia Islamia. The institutional tie-up proposed here will ensure the development of appropriate training modules on peace education to children in J&K. This material, once finalized and used, has the potential of being formally adopted as part of teacher training provided by the State Government. As Save the Children works in close cooperation with the State Government of J&K, the organization will advocate for this integration.
- b. A strong partnership between NM Centre for Peace and Conflict Resolution, Jamia Millia Islamia and Save the Children is intended for 1) creating a resource pool of 40 teachers; 2) developing appropriate and context-specific Peace Education material for school children and advocating with the government on its integration with teachers training provided by the State.
- c. Peace-building activities will be promoted, focused on making people aware of the concept of schools as a safe place, particularly as a place where the young can transcend ethnic and religious divides, free from external influences and interference. Gaining respect for this concept will be key focus of these activities.
- d. Art competitions will be held around the year, with the best work being



exhibited at a show in Srinagar on 21 September, to coincide with UN International Day of Peace when the project will promote a range of peace related celebrations.

e. Chief Protection mechanisms will be established in the 20 schools, through the implementation of child protection policies in each school. Teachers and students will be trained on child rights & child protection and on child safeguarding policies. The enforcement and respect for child protection mechanisms and their ability to respond to child safeguarding issues will be ensured through regular monthly meetings and reviews of the 20 student forums.

#### 4. TIME SCALE:

The duration of this arrangement will be for sixteen months beginning from January 2016 to April 2017, unless terminated earlier as provided in the miscellaneous provisions here-to.

#### 5. Fee:

- a. The service provider namely the first party Jamia Millia University shall be paid an amount of INR 450,000 (Four lakhs fifty thousand only) for module development and conducting the workshops on Peace Education.
- b. Tax deduction will apply to the amount which will be paid to Jamia Millia Islamia University in accordance with the prevailing income tax legislation/ policy of the Government of India.
- No other expenses/ charges including that for insurance purpose is payable to the service provider
- d. A copy of the Budget & timeline for project activities to be signed by the Second Party is enclosed as Schedule I to this Memorandum of Understanding.

#### 6. Miscellaneous:

- a. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both Jamia Millia Islamia and Save the Children Society.
- b. The parties of this Memorandum may, by mutual consent, add modify, amend, delete review or revise any term(s) and condition (s) of this Memorandum of Understanding.
- c. The intent and implementation of this Memorandum is subject to the policies of the respective states/ countries (in case of international agreements) and the laws of the land.
- d. This memorandum of understanding shall remain in focus for a period of sixteen months from the date of its signature and seal, and may be

terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the Memorandum of the Understanding. All the rights, obligations and corresponding duties flowing and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

- The parties to this memorandum of Understanding undertake to treat as e. "confidential and privileged" all information shared by either party in terms of the present Memorandum of Understanding. The terms of Confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- f. This Memorandum of Undertaking shall require the ratification of the competent Academic/ Executive body of the First Party Jamia Millia Islamia and the concerned Managing Committee of the Save the Children, Bal Raksha, Bharat Society.
- The Delhi Courts will have exclusive jurisdiction if any dispute arises g. between the parties.
