JMI organises regional seminar on Investor Education in collaboration with SEBI & MCX

Significance of investor education for the students and youth was discussed at a regional seminar organised by Department of Commerce and Business Studies, Jamia Millia Islamia (JMI) to celebrate World Investor Week from 30th September 2019 to 5th October 2019 .

About 200 students from various Faculties, Departments and Centers of the university participated in the 'Regional Seminar on Investor Education' to mark the occasion.

The seminar was organised in collaboration with two premier institutions viz, Securities & Exchange Board of India (SEBI) and Multi Commodity Exchange (MCX) of India Ltd.

This was the second such seminar held to provide valuable insights about Financial Markets, Commodity Derivatives Market and investor education.

The seminar was chaired by Prof. Ravinder Kumar, Head, Department of Commerce and Business Studies, and Co-chaired by Dr.Naseeb Ahmad, Student's Advisor. 
