Covid-19: JMI issues guidelines for students and staff

Jamia Millia Islamia(JMI) has taken several decisions in view of the rising Covid-19 cases in Delhi/NCR. It has been decided in the meeting of the committee which included Deans of Faculties and other officials of the university held on 07.04.2021 that;

1. Wearing a mask is mandatory and there will be no entry without a mask in the campus.
2. All students are advised to stay at home and avoid physical presence for their academic work, library, laboratory etc. unless it is very essential. All COVID- 19 Standard Operating Procedure (SOP) has to be followed to enter campus for academic activities and essential work which includes thermal screening at gates, wearing of mask, social distancing, no spitting in public places and entry with only valid identity proof along with the purpose of visit to the University Campus etc.
3. Booking of conference halls/auditorium/seminar halls etc. will remain cancelled till further notice.

The Committee has also decided to constitute a Corona Control Committee, JMI consisting of the following:
