Beyond her university endeavours, she has also held significant leadership roles, including President of the Women's Indian Chamber of Commerce and Industry's Delhi Legal Rights Consortium (WICCI-DLRC), Chief Operating Officer at the Grinspire Welfare Foundation, and Head of Mooting Advocacy Programmes at the Maldives Moot Court Society. Moreover, Aafreen excelled in moot court competitions both nationally and internationally during her time at Jamia.

Her professional journey spans some of India's most respected legal and human rights institutions, including the National Human Rights Commission of India (NHRC), the Office of Senior Advocate Dr. Pradeep Rai, and leading law firms such as Lakshmikumaran & Sridharan Attorneys, along with several prominent NGOs and advocacy organisations.

Aafreen said, "Jamia Millia Islamia has been instrumental in shaping my values, skills and commitment to justice. This scholarship is not just an academic achievement, it is a pledge to bring positive change to my home state Jharkhand and beyond."

After completing her LL.M., Aafreen intends to return to India to work on legal policy reforms, improve the effectiveness of justice delivery systems, and lead initiatives that promote fairness, equity, and dignity for all sections of society.
